Compliance Statement

The Board, in its capacity as the governing body of Abertay Housing Association, is satisfied that Abertay Housing Association is compliant with the requirements of Chapter Three of the Regulatory Framework and the Regulatory Standards of Governance and Financial Management.

Gaining assurance

The Board has gained this satisfaction from being involved in the formulation and evaluation of a comprehensive compliance framework of evidence and an action plan. The Coronavirus Pandemic COVID-19

With regard to compliance, the Board has monitored and taken account of the serious and devastating health and financial implications associated with the coronavirus pandemic. The Association has adapted our business plan, adjusted our strategic and operational activities and we have adjusted our annual budget and financial assumptions to take account of the serious health and financial implications. Ongoing monitoring

The Annual Assurance Statement Evidence and Action Plan Framework will be constantly updated by management and monitored by the Board to ensure suitable and sufficient oversight and scrutiny and provide continuous assurance that the Association maintains compliance with Chapter Three of the Regulatory Framework and Regulatory Standards of Governance and Financial Management.

The Board is mindful of its obligation to notify the Scottish Housing Regulator, via the Notifiable Events procedure, should an event, act or omission to act, be material to the Association's compliance with Chapter Three of the Regulatory Framework and the Regulatory Standards of Governance and Financial Management. It is with this obligation in mind that the Scottish Housing Regulator has been kept informed by way of the submission of Notifiable Events throughout the coronavirus pandemic.

Improvement focus

Having achieved compliance in March 2021 our focus will now be on maintaining and enhancing compliance. It is with enhancing compliance in mind that the Association gives the assurance that it has an effective approach to the collection of equalities information and that it will continue to consider and respect equality and human rights in all that it does.
