



## **Assurance Statement**

**September 2025**

We comply with most of the regulatory requirements set out in Chapter 3 of the Regulatory Framework. This includes:

- All relevant standards and outcomes in the Scottish Social Housing Charter;
- All relevant legislative duties; and
- The Standards of Governance and Financial Management.

## **Supporting Evidence**

We confirm that we have reviewed evidence that supports our assessment of compliance. This is based on a range of reports, policies, advice and information that we monitor on an ongoing basis. This includes:

- Regular reports about key performance information;
- Internal Audit reports;
- External Audit reports;
- Outcomes of tenant consultation exercises;
- Benchmarking;
- Reports, advice and information from senior staff and external sources; and
- Access to information regarding all Standards through our Board portal. We are confident that this is updated regularly; it includes cross-reference to all matters considered by the full Board and Audit Committee on an ongoing basis.

## **Other Information**

Since publication of our 2024 Assurance Statement, we have:

- Conducted a detailed review of Regulatory Standards 1 and 6;
- Considered progress on the actions identified from the 2024 assessment;
- Received a clean audit report from our External Auditor; and

## **Tenant and Resident Safety**

We are satisfied that we have made considerable progress in addressing the issues we identified previously in respect of duties relating to gas, electrical, fire and water safety and our obligations relating to asbestos, damp and mould. We are aware that there are a small number of issues still to be fully addressed. As these relate to the health and safety of tenants, we continue to assess these as material. We continue to regularly review and refine the Action Plan that is in place to address these. We have commenced an annual programme of internal audits that will focus on the key aspects of our Tenant and Resident Safety Strategy. In 2024 the focus was on gas servicing/compliance.

We have assessed our stock for the presence of RAAC and have identified that no properties are affected.

### **Equality Data Collection and Approach to Human Rights**

We continue to collect information regarding equalities on an ongoing basis (as part of household reviews). This is done anonymously unless customers give us specific consent to hold the information against their tenancy record. We recognise that we need to do further work on analysis of the data collected. We will be collecting equalities data as part of the Tenant Satisfaction Survey that is planned for Sept/October 2025. This is included in the Action Plan considered and approved by the Board at our meeting on 27 August 2025.

Equality Impact Assessments are conducted in respect of all policy reviews. Reference to any matters that have implications in respect of human rights issues are included in all relevant reports.

### **Publication**

We confirm that this Assurance Statement is being published on our website on the same date that it is submitted to the Scottish Housing Regulator.
